

Privacy Policy – Cate Fox Dietitian

1. We respect your privacy

- 1.1. Cate Fox Dietitian respects your right to privacy and is committed to the safeguarding the privacy of our clients and website users. We adhere to the Australian Privacy Principles contained in the *Privacy Act 1988 (Cth)*. This policy sets out how we collect and treat your personal information.
- 1.2. "Personal information" is information we hold which is information that identifies you.

2. Collection of personal information

- 2.1. Cate Fox Dietitian will, from time to time, receive and store personal information you enter onto our website, provide to us directly or give to us in other forms.
- 2.2. You may provide basic information such as your name, phone number, address and email address to enable us to send information, provide updates and process your product or service order. We may collect additional information at other times, including but not limited to, when you provide feedback, when you provide information about your personal or health status, change your content or email preference, respond to surveys and/or promotions, or provide financial or credit card information.

3. How we collect your personal information

3.1. We may receive personal information from third parties. If we do, we will protect it as set out in this privacy policy.

4. Use of your personal information

- 5.2. We may from time to time need to disclose personal information to comply with a legal requirement, such as law, regulation, court order, subpoena, warrant, in the course of a legal proceeding or in response to a law enforcement agency request.

- 5.3. We may be required to disclose personal information in corresponding with your referring medical practitioner regarding your treatment and care. If you are a Medicare or NDIS client, the Department of Human Services or the NDIA could request to see your medical records. Private health funds can also request access to client files for proof that a consultation has taken place.
- 5.4. We may also use your personal information to protect the copyright, trademarks, legal rights, property or safety of Cate Fox Dietitian, http://www.catefoxdietitian.com.au, its customers or third parties.
- 5.5. Information that we collect may, from time to time, be stored, processed in or transferred between parties located in countries outside of Australia.
- 5.6. If there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law, our uses databases, together with any personal information and non-personal information contained in those databases. This information may be disclosed to a potential purchaser under an agreement to maintain confidentiality. We would seek to only disclose information in good faith and where required by any of the above circumstances.
- 5.7. By providing us the personal information, you consent to the terms of this Privacy Policy and the types of disclosure covered by this policy. Where we disclose your personal information to third parties, we will request that the third party follow this Policy regarding handling of your personal information.

6. Security of your personal information

- 6.1. Cate Fox Dietitian is committed to ensuring that the information you provide to us is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure information and protect it from misuse, interference, loss and unauthorised access, modification and disclosure.
- 6.2. The transmission and exchange of information is carried out at your own risk. We cannot guarantee the security of any information that you transmit to us or receive from us. Although we take measures to safeguard against unauthorised disclosures of information, we cannot assure you that personal information that we collect will not be disclosed in a manner that is inconsistent with this Privacy Policy.

7. Access to your personal information

- 7.1. You may request details of your personal information that we hold about you in accordance with the provisions of the *Privacy Act 1988 (Cth)*. A small administrative fee may be payable for the provision of information. If you would like a copy of the information which we hold about you or believe that any information we hold on you is inaccurate, out of date, incomplete, irrelevant or misleading, please email us at hello@catefoxdietitian.com.
- 7.2. We reserve the right to refuse to provide you with information that we hold about you, in certain circumstances set out in the Privacy Act.

8. Complaints about Privacy
